D. Budget Augmentation 2025 - Sandi Lehman

Sandi presented the augmentation for the year 2025, as we close the end of year the expenses need to be adjusted. An augmentation of \$800,00 is needed for increases in staffing, permanent or contract, and supplies. Patient revenue is also over budget, causing the rise in supply expenses for the year for medications and infusion supplies. This estimate includes PERS adjustments of about \$150,000. The 2025 Budget Augmentation was approved with a motion by Karen Womack and seconded by Kelli King. Motion carries.

E. Financial Report – Sandi Lehman

The financial report for May 2025 was reviewed by Sandi. May ended with an operating income of \$71k YTD operating loss of \$341k, closing the gap between loss and revenue. Slightly under budget for the month, but over budget YTD. Under budget for the month for supplies and over budget YTD. Current cash balance of \$3.4 million. The AR balance has dropped \$400k since May. A motion to approve the May 2025 Financial Report was made by Paula Viani-Reed and seconded by Karen Womack. Motion carries.
